

- I. This amendment to Request for Proposals (RFP) No. DACS08P2215 provides:
- A. Section K: To update K.6 Identification of All Subcontractors; and
 - B. Section L: To update proposal page limitation of L.6.3.2.

II. SECTION K – REPRESENTATIONS, CERTIFICATIONS AND OTHER STATEMENTS OF OFFERORS

Replace **K.6 IDENTIFICATION OF ALL SUBCONTRACTORS** with the following:

K.6 IDENTIFICATION OF SUBCONTRACTORS

Identify subcontractors with proposed costs of \$1,000,000 or more per year and/or total anticipated expenditures of \$13,500,000 over the total contract period to perform any portion of this contract (including those assignable subcontracts listed in Section J, Attachment 7, Assignable Subcontracts, Leases, Charters, and Operator Agreement Listing meeting this dollar threshold) by providing the information set out below in paragraphs a, b, c, d, e and f.

Offerors proposing alternate subcontractors, regardless of costs, to those set out in the Section J, Attachment 7 listing, must result in an offeror proposed change page for Section J, Attachment 7, which accurately lists assignable subcontractors, leases, charters and operation agreements which will be in effect as of April 1, 2012 (also reference Section L.8.2i)).

Although it is the prime offeror's responsibility to perform an analysis and make a determination of responsibility for each prospective subcontractor IAW FAR 9.104, only information on proposed subcontractors meeting the above stated \$1,000,000 or more per year and/or total anticipated expenditures of \$13,500,000 over the total contract period need be provided as follows:

- a. **Subcontractor's Firm Name** with corresponding DUNS number and CAGE code
- b. **Subcontractor's address**
- c. **Subcontractor's point of contact, title, address and phone number**
- d. **Subcontractor's dollar amount under the ASC**
- e. **Subcontractor's role in the ASC:** Provide a description of the services/materials to be provided by the prospective subcontractor.
- f. **Subcontractor Responsibility:** Provide current ("current" is defined as within the past year, as appropriate) written evidence of the proposed subcontractor's responsibility addressing all relevant responsibility areas and issues as required by FAR 9.104. Offeror shall propose risk mitigation measures which offeror will undertake to ensure offeror/subcontractor responsibility for any area which is not adequately supported, e.g., a subcontractor with a non-approved accounting system where a cost-type contract was proposed, would require the offeror to provide supporting documentation to ensure sufficiency of the proposed subcontractor accounting system's ability to accumulate costs. At a minimum, the following responsibility elements must be addressed for proposed subcontractors with \$1,000,000 or more per year and/or total anticipated expenditures of \$13,500,000 over the total contract period:
 - 1. **Subcontractor's Financial Resources:**
 - 2. **Subcontractor's ability to comply with delivery/performance schedule:**
 - 3. **Subcontractor's Performance Record:**
 - 4. **Subcontractor's Record of Integrity & Business Ethics:**
 - 5. **Subcontractor's Organization, Experience, Accounting & Operational Controls, and Technical Skills:**
 - 6. **Subcontractor's Production, Construction, and Technical Equipment & Facilities:**

7. Subcontractor's Qualifications and Training that support them being qualified and eligible for the sub-award under applicable laws and regulations.

Section L.6.3 PROPOSAL PAGE LIMITATION AND SUBMISSIONS

Subparagraph L.6.3.2 is amended as follows:

The first sentence is amended to read: "Volume II, Technical, is limited to 325 pages."

The last sentence is amended to read: "Key Personnel resumes shall be limited to three (3) pages each and are excluded from the 325 page limit."
